







Mr. Deodat Sharma Chairman of CAROSAI

Mr. Deodat Sharma joined the Audit Office in April 1980. He was appointed Auditor General of the Co-operative Republic of Guyana on 31st of October 2012, having acted from the 1st of January 2005 to the said date.

He is a graduate of the University of Guyana with a Bachelor's Degree in Accounting. He was a fellow of the Canadian Comprehensive Auditing Foundation (CCAF-FCVI) from 1999-2000.

Mr. Sharma served on the CARICOM Secretariat Audit Committee from 2011 to 2015. He is currently working towards creating a paperless auditing environment through the use of Audit Management Software TeamMate.

Mrs. Pamela Monroe Ellis Secretary General of CAROSAI

Mrs. Pamela Monroe Ellis was appointed Auditor General in 2008, having spent the early part of her career at PricewaterhouseCoopers. She is a fellow of the Institute of Chartered Accountants of Jamaica (ICAJ), and the Association of Chartered Certified Accountants (ACCA, UK).

Ms. Heather Thomas became the third Auditor General of Bermuda, having previously served as Director of Internal Audit for the Government of Bermuda. She has 24 plus years of extensive governance, risk management audit and accounting experience. she has also held various senior roles in both public and private sectors in Bermuda, Hong Kong and the U.S.A.
